#### CAPTAIN'S REPORT

Summarising the 1965-66 Season, I cannot help but express my sincere satisfaction at the team spirit amongst Club Members. Although the Club is not strong at competition, I feel this spirit is making a strong foundation of principles for future years.

During this Season, patrols showed a higher degree of efficiency, this was mainly due to the generosity of the Bank of N.S.W. in donating a reel for a Patrol Competition State Centre and the combined efforts of our Club Captain for the first part of the Season, Geoff Price, and our Chief Instructor, George Hann, who instructed and tested patrol members in the art of performing Expired Air Methods and Sylvester-Brosch. Next Season we should be able to expand on these tests by formulating a Patrol Competition which will enable all facets of life-saving, this I hope will enable us to win the Bank of N.S.W. Patrol Competition quite easily and thus bring much credit to our Club.

At this stage of my report I would like to thank Dr. Alan McKinnon for his first aiding, this phase of Life Saving usually is performed by patrol members, but I am sure all members will agree that Alan performed these tasks in a far more professional manner than we can ever hope to attain.

Instruction of Bronze Candidates was effectively performed by various members, but much time is wasted by trying to train members who are not strong swimmers. Every prospective member should be able to swim 440 yards in 8 minutes before his application is accepted and Bronze Training is commenced.

Competition at carnivals was not without success, the 'A' Boat Crew showed stamina, surf provess and determination towards training, which was encouraged ably by Don McLeod. All of these efforts were climaxed by winning the State Title. The relay teams showed promise, members of these teams must feel, with early organised training next season, they will make their presence felt in beach events.

Swimming is only average, but there is definitely sufficient material to front up a first class Rescue and Resuscitation Team, this is a must for next season. Board riders have seemingly disappeared from the Club's ranks, with the exception of David Ferret who performed well at one carnival, let's hope next season will bring forth those board riders who once prided themselves on their riding ability.

I wish to thank members and friends who have assisted the Club by participating in the Social Committee functions, these persons will make the new Club House possible, therefore enabling us to provide more efficient life-saving facilities for the public.

In conclusion, I wish to state that I am extremely proud to be Captain of SOUTH-PORT, as our Club has attracted a different class of membership compared with other clubs. This is not only my opinion but also officials of the Association and members of the public. I hope this trend will continue, but this, of course, is completely up to ourselves to create a tradition which is hard to change.

Next Season we must continue to progress, especially if training and club activities are planned early and effectively performed.

#### BOAT CAPTAIN'S REPORT

Pre-season training commenced in early September and consisted mainly of Beach work and general conditioning of interested members on Sundays and one night during the week, until mid October. stage, renovations and maintenance of the Boat which are carried out during the Winter recess were completed, and a crew was selected to commence training. Training was conducted over three weekly sessions but it was not until the Christmas-New Year period that we were able to obtain a settled crew. However, the intervening period was by no means wasted as a considerable amount of experimentation went into stroking, turning, starting and getting the general feel of our Boat This was necessary, as our Boat is of comin various conditions. pletely different design to any other in South Australia. fore had no past experiences to draw on and only a few of the crew had any experience in handling the Boat from previous seasons. first experience in competition was at our own Carnival, held early November, in which we took out 3rd place. This gave everyone quite a "shot in the arn" and from then on attitude generally became more enthusiastic, apart from maybe one or two carnivals, the crew was always amongst the placegetters. For approximately five weeks prior to the

State Titles, training was increased to five sessions per week and this meant crew members were giving something in the vicinity of ten to twelve hours a week to training. Although this amount of time may not be up to requirements, or even anything like that being put in by other crews, it was considered to be satisfactory and was in fact the most that could be obtained when the individual's commitments were considered.

At this stage a proposition was placed before the Club Committee that it pay for the crew to compete at the Australian Championships in Coolangatta. This proposition was subject to the crew obtaining satisfactory result at our State Titles and the extent of the support was limited by the Committee to \$120.00 - actual cost eventually coming out at \$54.00.

As all members are by now aware, the crew obtained the most satisfactory result possible by winning the Boat Race at the State Titles. This win has been called among many things "lucky". But I believe that luck played only a minor part and the win can be attributed to three things.

- 1. The amount of time spent early in the season in what I have previously described as "experimentation and getting used to the feel of the Boat".
- 2. The guts and determination of all crew members to give their utmost and even that little bit more where "efforts" were required.
- 3. The uncanny wave reading ability of our sweep "Snake". Not only did he pick his way out so that the boat took on no water, but he deliberately held the crew off the first wave that came along on the way home because the wave behind was more suitable. His judgement here was indicated when one considers that the wave that swamped the West Beach crew was the one Snake let go.

It can therefore be seen that our win on this day can be attributed to what I call a better understanding of (a) our Boat on the day, (b) the conditions prevailing.

We are indeed fortunate to have a sweep of the calibre of Snake and, with the experience he gained in competition this year, I would rank him as South Australia's best and among the top twelve in Australia. The best way to see his ability is to suggest that one day when he takes a crew round to Horseshoe Reef on a training run, and there is a wave running which has either a perfect left or right curl, ask him to cut the curl and either "flick out" or "drop in" - he'll be happy to oblige!

As a result of our win the crew departed for Queensland amid what I must say was a blaze of publicity, and in this direction we are extremely grateful to Mr. Len James of 5AD, The Advertiser, Mr. Anderson of SAS1O and our own member Mr. Craig Nottle of NWS9. By this time,

crew member Bob Mayo had successfully completed negotiations with Esso Standard Oil (Aust) for Sponsorship of the crew. The club, and especially those members who made the journey, are most appreciative of this gesture.

From reports that have been given to me by those who made the trip, our crew performed creditably and were unfortunate in not getting any further than their heat. Four boats, ours included, crossed the line with only a matter of two feet separating the bows. However, the experience gained from interstate competition and discussions with interstate crew members and boat builders should be of benefit in the future.

To those fellows who comprised our crew, I say many thanks for your perseverance and dedication. We had some anxious moments but the final results justified and compensated for these. Crew members were as follows:-

G. D. (Snake) Ferrett - Sweep
B. S. J. Robb - No. 4 (Stroke)
M. J. Syms - No. 3
J. L. Huddy - No. 2
R. T. Mayo - No. 1 (Bow)

Now I feel I should comment on the Boat and equipment in general. I get the impression that some of our members feel that too much emphasis is placed around both the boat and crew. In this regard I would like to bring the following to the attention of all members.

- 1. A Surf Boat is the most expensive item of present day equipment purchased by a club. At present prices, a fully equipped boat would cost in the vicinity of \$1,350.00 new.
- 2. It being the most expensive individual item of equipment, it should be maintained properly. This not only requires money but a considerable amount of time and effort. I would conservatively estimate that during last season, including the winter reconditioning period, 400-500 man hours were spent to keep the boat in good condition. The money and time spent is well invested from the Club's point of view as our boat is in much better condition than some only two seasons old. In fact, there are boats in this State that are only two or three seasons old and need replacing.
- 3. However, because of the heavier work performed by our Boat (i.e. in Surf) I feel that the club should seriously consider investing in a new craft, as ours can no longer be considered suitable for top performances in tough competition. In other words, our boat has seen its competitive life although it is still an extremely useful work or second boat. The only other alternative to a new boat is to have our present boat extensively overhauled and modified as necessary to conform to present specifications. However, this would only give another season's competitive use before it would be essential to acquire another boat.

- 4. It is a general practice to acquire a new set of oars at least once a season as during the winter recess oars tend to lose their flexibility and become more susceptible to breaking. I do suggest that new oars should be purchased but that they not be obtained until mid January each year. I feel it will not affect training if the previous season's oars are used until this date, and by leaving purchases until this time the following advantages are evident:
  - a. The crew should be finalised and training successful.
  - b. The crew still has time to become accustomed to the new oars by the time of the Titles and make any minor adjustments.
  - c. The oars will have much more flexibility at that time of the season when this flexibility is of great value.
  - d. Their is morale booster in receiving new equipment.

These comments are made on the assumption that nothing unforeseen happens.

It is my suggestion that next season every member should learn how to pull an oar and other sweeps be trained under the guidance of Snake.

In closing I suggest that nothing be done to the Boat without first consulting David Ferrett.

I wish the Club and its members all the best for the forthcoming season and trust that some of the other members will devote some time to training for other aspects of competition as offered by the movement.



#### TREASURER'S REPORT

Again it is my pleasure to present the financial statement of the Southport Surf Lifesaving Club. The attached Reports covering the year ended 30/6/66 reveal the extent of the Club's activities to that period.

During that time there have been many changes in policy and functions of the Club. Whilst maintaining a high degree of efficiency in our practical lifesaving, the Club's name has earned a great deal of prestige in the organising of social activities.

Unfortunately, in this endeavour some of us have lost sight of our objectives, and I would suggest that before taking office for the ensuing season we must take stock of ourselves and realise that the efforts put in by us as individuals should be for the benefit of the Club generally and not used to our own ends.

Throughout the period under review there have been steady appropriations to our Deposit Stock Account with the Savings Bank of S.A.
